**SUSPENDING THE RELEASE AND PUBLICATION OF TOPNOTCHERS FOR
THE OCTOBER AND DECEMBER 2021 LICENSURE EXAMINATION FOR
CERTIFIED PUBLIC ACCOUNTANTS**

WHEREAS, with the National Capital Region (NCR) still under General Community Quarantine Alert Level 4 where activities characterized as high-risk for transmission such as examinations shall not be allowed pursuant to the guidelines on the pilot implementation of alert levels system for COVID-19 response in the NCR, the Professional Regulation Commission (Commission), on October 5, 2021, issued Resolution No. 1431 (s. 2021) rescheduling the October 2021 Licensure Examination for Certified Public Accountants (LECPA) in the NCR to December 16, 17 & 18, 2021;

WHEREAS, in the same Resolution, it was also resolved that the October 2021 LECPA shall proceed as scheduled in Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Koronadal, Legazpi, Lucena, Pagadian, Pampanga, Rosales, Tacloban, Tuguegarao, and Zamboanga;

WHEREAS, as of September 27, 2021, the total number examinees who were scheduled to take the October 2021 LECPA in the NCR is 6,305, which is more than half of 11,218 which represents the aggregate total number of LECPA examinees nationwide;

WHEREAS, the actual total number of examinees who took the October 2021 LECPA in the aforementioned participating venues was 2,317 which is clearly not representative of the whole population of this batch of examinees;

WHEREAS, considering the foregoing and in view of the rescheduling of the October 2021 LECPA in the NCR to December 2021, the Professional Regulatory Board of Accountancy (Board) deemed it wise and proper to recommend to the Commission the suspension of the release and publication of the topnotchers for the October and December 2021 LECPA;

WHEREFORE, premises considered, the Board **RESOLVES**, as it is hereby **RESOLVED**, to recommend to the Commission the suspension of the release and publication of the topnotchers for the October 2021 and December 2021 LECPA.

This Resolution shall take effect immediately upon approval of the Commission.
