RESCHEDULING THE AUGUST 2022 PROFESSIONAL FORESTERS LICENSURE EXAMINATION FROM AUGUST 10-11, 2022 TO OCTOBER 26-27, 2022 AND EXTENDING THE DEADLINE OF FILING OF APPLICATIONS FROM JULY 11, 2022 TO SEPTEMBER 27, 2022

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, Section 13 of R.A. No. 10690 or “The Forestry Profession Act” provides that applicants for registration for the practice of forestry shall be required to pass a licensure examination in such places and dates as the Commission may designate in a Resolution mandating the Master Schedule for all licensure examinations;

WHEREAS, the Commission issued Resolution No. 1439 (s. 2021) scheduling the Professional Foresters Licensure Examination (PFLE) on August 10-11, 2022 in the National Capital Region, Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Koronadal, Legazpi, Lucena, Pagadian, Pampanga, Rosales, Tacloban, Tuguegarao, and Zamboanga. The deadline for the filing of applications is on July 11, 2022;

WHEREAS, the Philippine Forestry Education Network, Inc. (PFEN) requested for the rescheduling of the August 2022 PFLE to October 2022, similar to the 2021 PFLE schedule, in consideration of the impacts of the pandemic as cited in its May 11, 2022 letter to the Commission and the Professional Regulatory Board for Foresters (Board);

WHEREAS, the Board and the Licensure Office find the request meritorious and are, thus, inclined to recommend to the Commission its approval.


WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **RESCHEDULE** the August 2022 Professional Foresters Licensure Examination to **October 26-27, 2022**.

RESOLVED FURTHER, that the deadline of for the filing of applications shall be moved from July 11, 2022 to **September 27, 2022**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
