RESOLUTION NO. 1588

DESIGNATING PUERTO PRINCESA CITY, PALAWAN AS AN ADDITIONAL TESTING CENTER FOR THE DECEMBER 2022 LICENSURE EXAMINATION FOR CRIMINOLOGISTS

WHEREAS, Section 7(d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations**;

WHEREAS, pursuant to Resolution No. 1439 (s. 2021), the schedule of the Licensure Examination for Criminologists (LEC) will be on December 04, 05, and 06, 2022 in various testing centers nationwide;

WHEREAS, the Commission issued Resolution No. 1493 (s. 2022), otherwise known as the "Revised Guidelines and Procedures on the Designation of Additional Testing Centers for the Conduct of Local Licensure Examinations", which provides that additional testing centers for large-scale examination outside the city or province where the PRC Regional Office is located must have at least three hundred (300) prospective examinees;

WHEREAS, the Office of the Provincial Governor of Palawan requested the PRC MIMAROPA Regional Office (PRC RO IV-B) to consider Puerto Princesa City, Palawan as one of the testing centers for the December 2022 LEC and further expressed its willingness to help and extend any assistance to ensure the successful conduct of the said licensure examination;

WHEREAS, the LEC is considered a large-scale licensure examination and there are more or less three hundred (300) prospective examinees for the December 2022 LEC in Puerto Princesa City, Palawan;

WHEREAS, in its Memorandum dated October 06, 2022, PRC RO IV-B stated that it has no objection to the request designating Puerto Princesa City, Palawan as an additional testing center for the December 2022 LEC;


WHEREAS, the Board and the Licensure Office recommend the approval of the request in order to give the concerned examinees the opportunity to take the December 2022 LEC without unnecessary distant travel and additional expenses.

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **PUERTO PRINCESA CITY, PALAWAN** as an additional testing center for the **DECEMBER 2022 LICENSURE EXAMINATION FOR CRIMINOLOGISTS**.


All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
