**REOPENING OF FILING OF APPLICATIONS FOR THE OCTOBER 2024
METALLURGICAL ENGINEERS LICENSURE EXAMINATION
FROM SEPTEMBER 30, 2024 TO OCTOBER 06, 2024**

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1728 (s. 2023) scheduling the Metallurgical Engineers Licensure Examination (MELE) on October 22, 23 and 24, 2024 in various testing centers;

WHEREAS, the Commission issued Resolution No. 1836 (s. 2024) revising the schedule of licensure examinations from August to December 2024 wherein the MELE will be conducted specifically in the National Capital Region (NCR) and Davao;

WHEREAS, Resolution No. 1891 (s. 2024) was issued increasing the number of testing centers for the examinations scheduled from October to December 2024;

WHEREAS, Resolution No. 1891 (s. 2024) further provides that the October 2024 MELE shall be conducted in the NCR, Cagayan de Oro, Davao, Legazpi and Lucena;

WHEREAS, the Professional Regulatory Board of Metallurgical Engineering (Board) is recommending the opening of the filing of application from September 30, 2024 to October 06, 2024 to accommodate applicants who struggled to complete their documentary requirements for application;

WHEREAS, the proposed reopening will provide the applicants ample time to prepare and submit their documentary requirements to the Commission;

WHEREAS, the Board and the Licensure Office recommend to the Commission the approval of the request to reopen the filing of applications for the said licensure examination;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **REOPEN THE FILING OF APPLICATIONS** for the **October 2024 METALLURGICAL ENGINEERS LICENSURE EXAMINATION** from **September 30, 2024 to October 06, 2024**;

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
