**DESIGNATING CEBU, DAVAO, AND PAMPANGA
AS ADDITIONAL TESTING CENTERS FOR THE NOVEMBER 2021
AERONAUTICAL ENGINEERS LICENSURE EXAMINATION**

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, pursuant to Resolution No. 1283 (s. 2020), the schedule for Aeronautical Engineers Licensure Examination (AELE) is on November 16, 17 & 18, 2021 to be held in the National Capital Region (NCR);

WHEREAS, the Commission received a letter from the Professional Regulatory Board of Aeronautical Engineering (Board) requesting the opening of other PRC Regional Offices aside from the NCR to accommodate the examinees from the provinces who are hindered by imposed travel restrictions;

WHEREAS, the PRC Regional Offices of Cebu, Davao, and Pampanga manifested to open their areas as testing centers for the November 2021 AELE;

WHEREAS, the PRC Regional Offices of Cebu and Davao assured that they have the budgetary requirements, supplies, and manning complement for the conduct of the same;

WHEREAS, the PRC Pampanga has likewise assured that they have the supplies and manning complement to conduct the said licensure examination. As regards the budgetary requirements, the same will be provided by the Licensure Division;

WHEREAS, in view of the health measures imposed by the government to mitigate, if not contain, the spread of COVID-19 through, but not limited to, social distancing and travel restrictions from one place to another, the Board endorsed the inclusion of PRC Regional Offices of Cebu, Davao, and Pampanga as testing centers for the welfare of the prospective examinees from the provinces, allowing them to take the AELE without unnecessary distant travel and additional expenses.

WHEREFORE, the Commission **RESOLVES** as it hereby **RESOLVED**, to designate **CEBU, DAVAO, and PAMPANGA** as additional testing centers for the **November 2021 Aeronautical Engineers Licensure Examination**.

RESOLVED FURTHER, that necessary coordination be undertaken by the appropriate offices/divisions of the Commission to ensure the smooth and orderly conduct of said licensure examination in these testing centers.
