DESIGNATION OF OCCIDENTAL MINDORO AS AN ADDITIONAL TESTING CENTER FOR THE JULY 2014 BOARD LICENSURE EXAMINATIONS FOR PROFESSIONAL TEACHERS (BLEPT)

WHEREAS, the Commission issued Resolution Nos. 2013-782 and 2013-787, fixing the dates and places of the Board Licensure Examinations for the year 2014, with the Board Licensure Examinations for Professional Teachers (BLEPT) scheduled on July 27, 2014 in the cities of Manila, Zamboanga, Bacolod and in all PRC Regional Offices;

WHEREAS, the Professional Regulatory Board for Professional Teachers (Board) has received a request from Provincial Governor Mario Gene J. Mendiola to consider the province of Occidental Mindoro as one of the testing centers for the July 2014 BLEPT;

WHEREAS, in a letter dated January 3, 2014, the PRC Regional Office in Lucena City, has recommended to the Commission and the Board the approval of said request, in line with the Commission's thrust of making its services more accessible to its clientele.

NOW THEREFORE, in view of the foregoing considerations, the Board **RESOLVES**, as it is hereby **RESOLVED**, to designate Occidental Mindoro as an additional testing center for the July 2014 BLEPT, subject to the approval of the Commission.
