PROFESSIONAL REGULATORY BOARD OF OPTOMETRY Resolution No. 04 Series of 2014

RESCHEDULING THE JULY 2014 PRACTICAL EXAMINATION OF THE OPTOMETRY BOARD LICENSURE EXAMINATION TO JULY 14, 15 AND 16, 2014

WHEREAS, pursuant to Section 7 (d) of R. A. No. 8981 otherwise known as the PRC Modernization Act of 2000, the Commission issued Resolution No. 2013-782 dated September 24, 2013 which provides for the dates and venues of all professional licensure examinations for the calendar year 2014 as well as the deadline in the filing of applications, practical examinations, professional upgrading examinations, Special Professional Licensure Board Examination (SPLBE), and target dates of release of examination results;

WHEREAS, the Commission issued Resolution No.2013-787 dated November 26, 2013 which provides for the adoption of a master schedule of target dates of activities for the 2014 licensure examinations in order to ensure the orderly and smooth administration of licensure examinations from the preparation and encoding of test questions up to, and including, the release of test results;

WHEREAS, the written examination and practical examination of the Optometry Board Licensure Examination were scheduled on July 8, 9 and 10, 2014 and July 16, 17 and 18, 2014, respectively;

WHEREAS, the expenses of examinees, especially those coming from provinces, will be reduced if the interval between the administration of the written and practical examinations will be shortened;

WHEREAS, the Professional Regulatory Board of Optometry (Board) has coordinated and consulted with the concerned offices of the Commission on this proposed rescheduling of the practical examination;

NOW THEREFORE, the Board **RESOLVES**, as it is hereby **RESOLVED**, to reschedule the date of the Practical Examination of the Optometry Board Licensure Examination to **July 14**, **15 and 16, 2014**;

Let a copy of this Resolution be posted in the PRC official website and furnished the Board and other offices, divisions, and units of the Commission for their information and guidance.
