RESCHEDULING THE BOARD LICENSURE EXAMINATION FOR RADIOLOGIC TECHNOLOGISTS
AND X-RAY TECHNOLOGISTS FROM JUNE 5-6, 2014 TO JULY 3 -4, 2014

WHEREAS, pursuant to Section 7 (d) of R.A. No. 8981, known as the "PRC Modernization Act of 2000", the Commission issued Resolution Nos. 2013-782 and 2013-787 which provide for the schedule of the Board Licensure Examinations (BLE) for the calendar year 2014 and the deadline in the filing of all applications therefor;

WHEREAS, under these Resolutions, the Board Licensure Examination for Radiologic Technologists and X-ray Technologists has been scheduled on June 5 - 6, 2014 in the Cities of Manila, Iloilo and Davao;

WHEREAS, appeals have been received by the Board of Radiologic Technology to move the original examination date of the BLE for the Radiologic Technologists and X-ray Technologists to a later date to afford prospective examinees sufficient time to prepare for the examination;

WHEREAS, Board has made the necessary coordination with the Examination Division and other concerned offices/divisions of the Commission on this proposed rescheduling of the licensure examination;

NOW THEREFORE, in view of the foregoing considerations, the Board **RESOLVES**, as it is hereby **RESOLVED**, to reschedule the BLE for Radiologic Technologists and X-Ray Technologists to July 3 - 4, 2014, subject to the approval of the Commission;

RESOLVED FURTHER, that the last day for the filing of applications for this licensure examination is on June 13, 2014.

Let copies of this Resolution be furnished the Professional Regulatory Board of Radiologic Technology, Office of the Director for Licensure, Application Division, Examination Division, Rating Division, ESTF, ICT Division, Secretariat, Supply & Property Division, Budget Division, Accounting Division, Legal Division and all PRC Regional Offices for their information, guidance, and dissemination.
