 - d. Two or more pencils (No. 2)
 - e. Ballpen with BLACK INK ONLY
 - f. One (1) piece Long Brown Envelope
 - g. One (1) piece Long Transparent (non-colored) Plastic Envelope (for keeping your Valuables and other allowed items)
- 5. The following are prohibited inside the examination premises/rooms.
 - a. Books, notes, review materials and other printed materials containing coded data/information/formula.
 - b. PROGRAMMABLE CALCULATORS
 - c. SMART WATCH, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS and other electronic gadgets/devices which may be used for communication purposes.
 - d. Bags of any kind (place your documents inside the transparent/plastic envelope)
 - e. Other examination aides not stated in this program.
