The Professional Regulation Commission (PRC) announces that **41** out of **48** passed the Dental Technologist Licensure Examination given by the **Board of Dentistry** in **Manila** this **December 2016**.

The results were released in two (2) working days after the last day of examination.

Starting December 14, 2016, registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will be done on-line. Those who will register are required to bring the following: Notice of Admission, duly accomplished Oath Form or Panunumpa ng Propesyonal, 2 pieces passport size picture (colored with white background and complete name tag) and 2 sets of documentary stamps. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oath-taking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER**.
