**GEODETTIC ENGINEER LICENSURE EXAMINATION
 RESULTS RELEASED IN ONE (1) DAY**

The Professional Regulation Commission (PRC) announces that **154** out of **400** passed the Geodetic Engineer Licensure Examination given by the **Board of Geodetic Engineering** in **Manila** this **September 2010**.

The members of the Board of Geodetic Engineering who gave the licensure examination are **Engr. Benjamin O. Mindajao**, Chairman; **Engr. Restituto U. Bautista** and **Engr. Pedro L. Noble**, Members.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will start on Wednesday, September 8, 2010 but not later than September 22, 2010. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 2 pieces passport size picture (colored with white background and complete nametag), 1 piece 1" x 1" picture (colored with white background and complete nametag), 2 sets of metered documentary stamps, and 1 short brown envelope with name and profession; and to pay the Initial Registration Fee of P600 and Annual Registration Fee of P450 for 2010-2013. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The oath-taking ceremony of the successful examinees in the said examination as well as the previous ones who have not taken their Oath of Professional will be held before the Board on Friday, October 1, 2010 at 1:00 o'clock in the afternoon at the Manila Hotel, One Rizal Park, Manila.

Registration for membership with the **Geodetic Engineers of the Philippines, Inc. (GEP)** will take place after registration as professional with the Board and the Commission.
