**INTERIOR DESIGN LICENSURE EXAMINATION
RESULTS RELEASED IN THIRTEEN (13) WORKING DAYS**

The Professional Regulation Commission (PRC) announces that **172** out of **311** passed the Interior Design Licensure Examination given by the **Board of Interior Design** in **Manila** this **October 2012**. The result of examination with respect to one (1) examinee was withheld pending final determination of her liabilities under the rules and regulations governing licensure examination.

The members of the Board of Interior Design are **Sonia Santiago-Olivares**, Chairman; **Kathryn Milagrosa B. Abañó** and **Maria Carlota D. Hilvano**, Members.

The results were released in thirteen (13) working days after the last day of examination.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will start on Tuesday, November 13, 2012. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 2 pieces passport size picture (colored with white background and complete nametag), 1 piece 1" x 1" picture (colored with white background and complete nametag), 2 sets of metered documentary stamps and 1 short brown envelope with name and profession and to pay the Initial Registration Fee of P600 and Annual Registration Fee of P450 for 2012-2015. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oath-taking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER.**
