PARTIAL RELEASE OF THE RESULTS OF THE JANUARY 2014 BOARD LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS (BLEPT) IN CATARMAN, NORTHERN SAMAR AND BAYBAY CITY, LEYTE

WHEREAS, PRC Resolution Nos. 2013-782 and 2013-787 prescribe the dates and venues of the professional licensure examinations for calendar year 2014, with the Board Licensure Examination for Professional Teachers (BLEPT) scheduled on January 26, 2014 in the cities of Manila, Zamboanga and in all PRC Regional offices;

WHEREAS, the Commission designated Catarman, Northern Samar, as a special testing center, and Baybay City, Leyte, as an alternate testing site, for the January 2014 BLEPT, with the issuance of Resolution No. 2013-30, Series of 2013;

WHEREAS, the results of the January 2014 BLEPT were released by the Commission on March 07, 2014;

WHEREAS, pursuant to Resolution No. 2014-19, the Commission withheld the release of the results of the examinations that were administered in Catarman, Northern Samar and Baybay City Leyte, pending the re-evaluation and verification of the documentary submissions of the examinees:

WHEREAS, out of the two thousand eight hundred thirty (2,830) examinees from these provinces, nine hundred seventy three (973) examination results have already been released by the Commission, under Resolution Nos. 2014-25 and 2014-30;

WHEREAS, five hundred thirty (530) additional applications and documentary requirements have undergone re-evaluation and verification by the Commission;

NOW THEREFORE, the Professional Regulatory Board for Professional Teachers (Board) has **RESOLVED**, as it so **RESOLVES**, to release the examination results of these five hundred thirty (530) examinees, with the approval of the Commission.

Let copies of this Resolution be posted in the PRC official website and furnished the Board, Examination Division and other concerned offices/divisions/units of the Commission for information and dissemination.
