
1. Your school/building assignment will be posted at the PRC premises and at the PRC website (www.prc.gov.ph) one (1) or two (2) days before the examination. Bring your **NOTICE OF ADMISSION** when you verify your school/building assignment. Visit your school/building assignment prior to the day of the examination.
2. Report to the school/building assignment before 6:30 a.m. on the first (1st) day of the examination to verify your room and seat number. Be punctual, late examinees will not be admitted.

3. Examinees are required to wear the following attire every examination day:
Male Examinees - Plain white polo shirt with collar (without any seal, logo mark)
decent pants or slacks
- Female Examinees- Plain white Blouse or shirt with collar (without any seal, logo or mark)
decent pants, slacks or skirt
4. Bring the following on examination day:
- a. Notice of Admission
 - b. Official Receipt
 - c. One (1) piece metered-stamped window mailing envelope
 - d. Two (2) or more pencils (No. 2)
 - e. Ball pens with **BLACK ink only**
 - f. One (1) piece long brown envelope
 - g. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
