ACCREDITATION OF TRAINING PROVIDER FOR DETAILMEN/MEDICAL REPRESENTATIVES/PROFESSIONAL SALES REPRESENTATIVES

WHEREAS, Section 12 of Republic Act 5921, otherwise known as “An Act Regulating the Practice of Pharmacy and Setting Standards of Pharmaceutical Education in the Philippines and for other Purposes”, requires all detailmen employed by any pharmaceutical or drug laboratory or other manufacturers of medical, dental pharmaceutical, biological and veterinary products and by distributors, dealers or wholesaler to register with the Professional Regulatory Board of Pharmacy in accordance with such guidelines as may be promulgated;

WHEREAS, the Board issued Resolution No. 96, Series of 2015, entitled “Revised Guidelines on the Accreditation of Training Providers and Programs for Detailmen/Medical Representatives/Professional Sales Representatives” which provides for the requirements for accreditation of training providers and their programs;


WHEREAS, the Board issued Resolution No. 03, Series of 2015, entitled “Reinforcing the Legal Requirements on the Mandatory Registration of Detailmen/Medical Representatives / Professional Sales Representatives with the Professional Regulation Commission and the Professional Regulatory Board of Pharmacy” which mandates all detailmen/medical representatives/professional sales representatives to undergo comprehensive training program from accredited training provider prior to application for registration;

WHEREAS, the **DeGA INTERNATIONAL PHARMA CORP.** with office address at 710 Common Goal Tower Finance corner – Industry Sts., Madrigal Business Park, Alabang, Muntinlupa City filed its application for accreditation as training provider for detailmen/medical representatives/professional sales representatives in accordance with the provisions of the aforementioned Resolutions;

WHEREAS, upon perusal and careful evaluation of the application for accreditation and the documents submitted, the Board finds that **DeGA INTERNATIONAL PHARMA CORP.** has complied with all the requirements set forth in Board Resolution No. 96, Series of 2015;

WHEREFORE, the Board **RESOLVED**, as it hereby **RESOLVES**, to approve the application for accreditation of **DeGA INTERNATIONAL PHARMA CORP.**, as training provider for detailmen/medical representative/professional sales representatives and to issue thereto a Certificate of Accreditation upon payment of the prescribed fees. This Certificate of Accreditation shall be valid for a period of three (3) years, subject to renewal upon compliance with the requirements.
