RESOLUTION NO. 172 Series of 2016

ACCREDITATION OF TRAINING PROGRAM FOR DETAILMEN/MEDICAL REPRESENTATIVES/PROFESSIONAL SALES REPRESENTATIVES

WHEREAS, the Professional Regulatory Board of Pharmacy (Board) issued Resolution No. 03, Series of 2015, entitled "Reinforcing the Legal Requirements on the Mandatory Registration of Detailmen/Medical Representatives/Professional Sales Representatives with the Professional Regulation Commission (Commission) and the Board," which mandates all detailmen/medical representatives/professional sales representatives to undergo comprehensive training program from accredited training provider as a condition for their registration with the Commission and the Board;

WHREREAS, Board Resolution No. 96, Series of 2015 entitled, "Revised Guidelines on the Accreditation of Training Providers and Programs for Detailmen/Medical Representatives/Professional Sales Representatives" requires accreditation of training program of the accredited training provider prior to their offering;

WHEREAS, THE CATHAY YSS DISTRIBUTORS CO., INC. an accredited training provider, applied for accreditation their training program for medical representatives, entitled "The Cathay YSS Distributors Co., Inc. Medical Representatives Training Program" to be conducted from July 19 to August 26, 2016, at the Vernida I Condominium Training Room, 120 Amorsolo Street, Legaspi Village, Makati City in accordance with the said Board Resolution;

WHEREAS, upon perusal and careful evaluation of the application and documents submitted by THE CATHAY YSS DISTRIBUTORS CO., INC. for the said training program, the Board finds that the aforementioned application has satisfied the prescribed requirements;

WHEREFORE, the Board RESOLVED, as it hereby RESOLVES, to approve the application for accreditation of training program for medical representatives of THE CATHAY YSS DISTRIBUTORS, INC., entitled "The Cathay YSS Distributors Co., Inc. Medical Representatives Training Program". Upon approval of the Commission and payment of the prescribed fees, let their Certificate of Accreditation be issued accordingly.

FURTHER RESOLVED, that within thirty (30) days after the conduct of the said training program, THE CATHAY YSS DISTRIBUTORS CO., INC. is directed to submit their COMPLETION REPORT in the prescribed forms to the Board, through the Standards and Inspection Division.
