3. Examinees are required to wear the following attire every examination day:
 1. Male Examinees - Any scrub suit/white polo shirts or t-shirts with collar (without any seal, logo or mark), tucked-in decent pants/slacks
 2. Female Examinees - Any scrub suit/white blouses or t-shirts with collar (without any seal, logo or mark), tucked-in decent skirts or slacks

 - b. Official Receipt
 - c. One (1) piece of metered stamped Window Mailing Envelope
 - d. Two (2) or more pencils (No. 2)
 - e. Ballpen with BLACK ink only
 - f. One (1) piece Long Brown Envelope.
 - g. One (1) piece Long Transparent (non-colored) Plastic Envelope (for keeping your valuables and other allowed items)


5. The following are **PROHIBITED** inside the examination premises/rooms:
